Serving only sixth grade, we provide instruction aligned to the California Content Standards with an emphasis on critical thinking and problem solving. With ongoing evaluation of our students and programs, we strive to meet the individual needs of all.

### SCHOOL MISSION STATEMENT

Cypress Academy is a unique school in the Hesperia Unified School District serving only sixth grade students. Opening its doors for the first time in August of 2005, it is the intent of the Cypress staff to provide an effective academic and social transition from elementary school to the secondary level for all of our students. The school environment will be one to provide the nurturing support unique to the elementary level while incrementally providing the development of independence necessary for success at the secondary level. This development of independence will include a focus on organizational skills, critical thinking, and student interest. This will be evident in the structure of the school, as well as the instruction itself.

### SCHOOL PROFILE

Hesperia Unified School District is located in the high desert region of San Bernardino County, approximately 40 miles north of the Ontario/San Bernardino valley. More than 20,000 students in grades kindergarten through twelve receive a rigorous, standards-based curriculum from dedicated and highly qualified professionals. The district is comprised of 15 elementary schools, 2 sixth grade academies, 3 middle schools, 2 comprehensive high schools, 1 alternative school, 2 continuation high schools, 1 community day school, and 6 charter schools.

Cypress Academy is located in the southwest region of Hesperia. At the beginning of the 2007-08 school year, 611 sixth grade students were enrolled, including 7% in special education, 21% qualifying for English learner support, and 60% qualifying for free or reduced-price lunch. Cypress Academy achieved a 2008 Academic Performance Index (API) score of 757.

Parents are encouraged to volunteer in the classroom or library, chaperon field trips, and get involved in the decision-making process through school committees. Cypress Academy provides a safe, clean environment for learning through proper facilities maintenance and campus supervision. Original school facilities were built in 2005; ongoing maintenance ensures the campus remains safe and in good working condition and provides adequate space for students and staff. #### CAMPUS SUPERVISION

Five proctors, strategically placed in various areas of the campus, supervise students as they enter school grounds. During lunch, three proctors share supervision of the cafeteria and playground activities. When students are dismissed at the end of the day, assigned teachers and administrators monitor bus loading and student pickup areas to ensure students leave campus in a safe and orderly manner. School administrators, the custodian, and the school office are assigned hand-held radios at all times. Proctors and teachers carry hand-held radios when providing student supervision. Hand-held radios help facilitate quick and effective communications between school staff for routine and urgent situations.

#### CAMPUS MAINTENANCE

The custodial staff and district's maintenance department work together to ensure playgrounds, classrooms, and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. The principal and lead day custodian communicate daily each morning regarding maintenance issues and special projects.

One full-time day custodian, 1 full-time evening custodian, and one part-time night custodian are assigned to Cypress Academy; the day custodian relays direction from the principal to evening custodian for routine maintenance, daily custodial duties, and special events. Every morning before school begins, the day custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. School administrators and the day custodian check restrooms frequently throughout the day as a proactive measure in keeping restrooms stocked, safe, and sanitary. The evening custodians clean classrooms, desks, office areas, and restrooms, and are responsible for set up and take down of equipment and/or furniture for afternoon and evening events.

Cypress Academy works closely with the district's Maintenance & Operations (M&O) department for larger projects, routine facilities maintenance projects, and school inspections. The most recent facilities inspection at Cypress Academy took place on September 4, 2008. M&O employs a work order process that enable Cypress Academy to communicate unscheduled maintenance needs, urgent repairs, or special projects. The day custodian and school office staff are responsible for coordinating the preparation and submission of work orders to M&O for resolution. Emergency situations are regularly resolved in one hour or less.

## Planned Improvement

### DEFERRED MAINTENANCE

Hesperia Unified School District participates in the State School Deferred Maintenance Program which provides dollar-for-dollar matching funds to assist school districts with major repairs or replacement of existing school building components. Deferred maintenance projects generally include roofing, plumbing, heating, air conditioning, electrical systems, interior/exterior painting, and floor systems. During the 2007-08 school year, Cypress Academy received and was only eligible for a minimal amount, \$399 in deferred maintenance funds, for campus upkeep since campus facilities are less than five years old. The only project was some painting.

#### Textbook Information

All textbooks used in the core curriculum throughout Hesperia Unified School District are aligned to the California Content Standards and Frameworks. Instructional Materials for grades K-8 are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. Instructional materials for grades 9-12 are standards-based and approved by the district's Board of Trustees. The district follows the State Board of Education's six-year adoption cycle for core content materials and the eight-year cycle for textbook adoptions in foreign language, visual and performing arts, and health. District textbook review and adoption activities occur the year following the state's adoption. Parents are invited to preview proposed adoptions at the district office for one evening and ten days prior to approval by the school board. On September 9, 2008, the Hesperia Unified School District Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No.2008/09-24 which certifies as required by Education Code section 60119 (1) that textbooks and instructional materials were provided to all students, including English learners in the Hesperia Unified School District to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home to study, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts, (3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and (4) sufficient laboratory science equipment was provided for science laboratory classes offered in grades 9-11, inclusive.

All professional development activities in Hesperia Unified School District revolve around the California State Content Standards and Frameworks and are research-based. Certificated staff build teaching skills and concepts through participation in ongoing training sponsored by the district and school site. During the 2007-08 school year, the district made available one staff development buy-back day and supplemental training involving curriculum, teaching strategies, and methodologies in the content areas of writing and math. Each school site then identifies and coordinates its own staff development activities based upon individual student needs, school site plans, and the district's designated focus areas.

During the 2007-08 school year, Cypress Academy sponsored two days of staff development. Topics of training activities included:

- \*Program development
- \*Thinking Maps
- \*Cognitively Guided Instruction (CGI)
- \*AVID Elementary (Advancement Via Individual Determination)
- \*ELL (English Language Learners)
- \*Write For The Future/Write From The Beginning (WFTF/WFTB)

Supplemental and ongoing staff training takes place on "late start" Wednesdays and is embedded into regular staff meetings. All training activities focus on developing and supporting Cypress Academy's curricular program. Topics covered in supplemental training sessions included:

- \*Program development
- \*AVID Elementary
- \*Cognitively Guided Instruction
- \*GLAD Training (Guided Language Acquisition Design)
- \*ELL
- \*Write For The Future
- \*Thinking Maps
- \*New Teacher Support and Follow-up

Training topics were selected by the school Leadership Team and principal who analyze student assessment results and review teacher survey results. Structured training programs enable teachers to deliver a challenging and rigorous standards-based education fostering student success and proficiency.

The district supplements site-level professional development to follow up and support year-round and ongoing programs centered around the district's focus areas of reading and math. Supplemental professional development is offered throughout the school year on early student release days, during summer vacation, and on weekends. Staff development topics and focus areas are identified and selected based upon input from the district's Professional Development Committee, Principals' Roundtable, and teacher survey results. The Professional Development Committee meets once a year to review student test results from state and district assessments and review teacher survey needs. The Principals' Roundtable provides opportunities for school principals to discuss and share training needs based upon data analysis and classroom observations from each school site.

New teachers receive intensive support and training through the district's Induction Program and New Teachers Academy. For beginning and out-of-state teachers, the district utilized the state Induction Program (formerly known as Beginning Teacher Support and Assessment), a statewide and state-mandated research-based program providing support and skill building through formative assessment and individualized support based on assessment. The New Teachers Academy sponsors three new teacher orientations each year to support year-round hiring practices; the orientation is a comprehensive overview of the district's policies, school law, ExCEL philosophy, English language learners support, curriculum, instruction, and grade-level and content area specialties.
