By establishing a collaborative culture within our school community and focusing on providing a safe and positive learning environment, we share the responsibility with our families for making sure all students successfully achieve the established content and performance standards. In order to accomplish this mission, it is necessary for the entire staff, parents, and students themselves, to commit to doing whatever it takes to see that every child becomes a skilled and enthusiastic learner. The district goal is for every school to reach an Academic Performance Index of 800 by 2010.

SCHOOL PROFILE

Hesperia Unified School District is located in the high desert region of San Bernardino County, approximately 40 miles north of the Ontario/San Bernardino valley. More than 20,000 students in grades kindergarten through twelve receive a rigorous, standards-based curriculum from dedicated and highly qualified professionals. The district is comprised of 15 elementary schools, 2 sixth grade academies, 3 middle schools, 2 comprehensive high schools, 1 alternative school, 2 continuation high schools, 1 community day school, and 6 charter schools.

Mesa Grande Elementary is located in the central region of Hesperia and serves students in grades Kindergarten through six. At the beginning of the 2007-08 school year, 738 students were enrolled, including 6% in special education, 34% qualifying for English learner support, and 65% receiving free or reduced-price meals. Mesa Grande Elementary achieved a 2008 Academic Performance Index (API) score of 762 and met all 2008 Adequate Yearly Progress (AYP) criteria.

At Mesa Grande Elementary, parents are encouraged to become active members in the school's learning community and assist in its goal to develop independent, self-reliant, lifelong learners. The school's brand new marquee display important announcements and reminders. The school web site is updated throughout the year and features general school information, schedules, and activities. Once every trimester, the principal hosts Pastries for Parents. In an informal, friendly social atmosphere, the principal encourages parents to discuss their concerns or simply get to know each other. Progress reports and report cards showing academic and behavioral performance are sent home for parent review each trimester.

SCHOOL FACILITIES AND SAFETY

Mesa Grande Elementary provides a safe, clean environment for learning through proper facilities maintenance and campus supervision. Original facilities were built in 1976; ongoing maintenance and modernization efforts ensure facilities remain safe and up to date and provide adequate space for students and staff. Throughout the years, portable classrooms have been added to accommodate increased growth in enrollment. The campus is comprised of the following:

CAMPUS SUPERVISION

Two proctors supervise the crosswalks and help students safely cross the street before and after school. Each morning before school starts, six proctors are assigned to designated areas of the campus to supervise students as they enter school grounds. During recess, teachers are on the playground to monitor behavior and playground activities. Proctors and administrators provide supervision during the lunch recess and monitor both cafeteria and playground activities. At the end of the day, administrator and teachers escort students to the bus loading area, student pickup area, and on-campus after-school programs to ensure students leave campus safely.

CAMPUS MAINTENANCE

The custodial staff and district's maintenance department work together to ensure playgrounds, classrooms, and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. The principal and custodians communicate daily regarding maintenance issues and special projects; hand-held walkie talkies enhance two-way communication efforts and help facilitate an immediate response to emergency situations.

Three full-time day custodians and two full-time evening custodians are assigned to Mesa Grande Elementary and are shared with Mesa Academy. Every morning before school begins, one of the day custodians inspects facilities for safety hazards and other conditions that need attention prior to students and staff entering school grounds. As part of the routine responsibilities, the day custodian keeps bathrooms, cafeteria, and campus grounds clean throughout the day. The evening custodians clean classrooms, desks, and restrooms, and are responsible for set up and take down of equipment and/or furniture for afternoon and evening events.

Mesa Grande Elementary works closely with the district's Maintenance and Operations department (M&O) for larger projects, routine facilities maintenance projects, and school inspections. The most recent facilities inspection at Kingston Elementary took place on August 27, 2008. M&O employs a work order process that enables Mesa Grande Street Elementary to communicate unscheduled maintenance needs, urgent repairs, or special projects. Emergency situations are regularly resolved in one hour or less.

DEFERRED MAINTENANCE

Hesperia Unified School District participates in the State School Deferred Maintenance program which provides dollar-for-dollar matching funds to assist school district with major repairs or replacement of existing school building components. Mesa Grande received \$71,391 for asphalt, carpet, concrete, HVAC, walls and doors improvement projects throughout the campus.

The district follows the State Board of Education's six-year adoption cycle for core content materials and the eight-year cycle for textbook adoptions in foreign language, visual and performing arts, and health. District textbook review and adoption activities occur the year following the state's adoption. Parents are invited to preview proposed adoptions at the district office for one evening and ten days prior to approval by the school board. On September 9, 2008, the Hesperia Unified School District Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No.2008/09-24 which certifies as required by Education Code section 60119 (1) that textbooks and instructional materials were provided to all students, including English learners in the Hesperia Unified School District to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home to study, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts, (3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and (4) sufficient laboratory science equipment was provided for science laboratory classes offered in grades 9-11, inclusive

XI. Instructional Planning and Scheduling

Professional Development

This section provides information on how teachers and staff are trained for instructional improvement.

All professional development activities in Hesperia Unified School District revolve around the California State Content Standards and Frameworks and are research-based.

Certificated staff build teaching skills and concepts through participation in ongoing training sponsored by the district and school site. During the 2007-08 school year, the district made available one staff development buy-back day and supplemental training involving curriculum, teaching strategies, and methodologies in the content areas of writing and math. Each school site then identifies and coordinates its own staff development activities based upon individual student needs, school site plans, and the district's designated focus areas.

During the 2007-08 school year, Mesa Grande Elementary held one staff development buy-back day to train the staff on the adopted science program and reinforce Balanced Literacy skills used in the classroom. Staff development topics were selected by the principal, assistant principal, and Staff Council. Training programs and topics were chosen based upon the school focus and student needs. Results for the California Standardized Tests and district benchmark assessments, teacher feedback, and findings from classroom observations help identify areas for improvement and training programs that will enable teachers to deliver a challenging and rigorous standards-based education fostering student success and proficiency.

The district supplements site-level professional development to follow up and support year-round and ongoing programs centered around the district's focus areas of reading and math. Supplemental professional development is offered throughout the school year on early student release days, during summer vacation, and on weekends. Staff development topics and focus areas are identified and selected based upon input from the district's Professional Development Committee, Principals' Roundtable, and teacher survey results. The Professional Development Committee meets four times a year to review student test results from state and district assessments and review teacher survey needs. The Principals' Roundtable provides opportunities for school principals to discuss and share training needs based upon data analysis and classroom observations from each school site.

New teachers receive intensive support and training through the district's Induction Program and New Teachers Academy. For beginning and out-of-state teachers, the district utilized the state Induction Program (formerly known as Beginning Teacher Support and Assessment), a statewide and state-mandated research-based program providing support and skill building through formative assessment and individualized support based on assessment. The New Teachers Academy sponsors three new teacher orientations each year to support year-round hiring practices; the orientation is a comprehensive overview of the district's policies, school law, ExCEL philosophy, English language learners support, curriculum, instruction, and grade-level and content area specialties.
